

DEFINITION OF QUALITY

High quality early care and education programs are those with demonstrated positive impacts on young children's development

DEFINITION OF QUALITY

Key components of these programs include highly-skilled staff that engage in warm, responsive interactions with children; have specialized care and education knowledge and skills; and implement developmentally appropriate curricula tied to formative child assessment



PERFORMANCE FUNDING PROJECT

- Year 3
- Modifications along the way based on feedback
- Commitment to quality is the foundation
- Goal is to transition to Performance Funding Project to a statewide Quality Rating Improvement System (QRIS)

PERFORMANCE FUNDING PROJECT

Quarterly Payments

• \$550 - \$32,560

Bonus Payments

• \$3,000 - \$30,000

Total Contracts

• \$7,000 - \$88,000

Factors involved include:

- Number of School Readiness children served
- High needs/poverty area
- Number of classrooms
- Benchmarks and outcomes/mastery

ACCREDITATION

- Of 158 contracted providers, 99 are not accredited (63%)
- Benefits of "going the extra mile"
- More than just minimum expectations
- Learning from the process (Self Assessment)
- Provides a tool and less "guessing" of what leads to higher quality services

ACCREDITATION SUPPORT GRANTS

- Accreditation before QRIS
- Coalition shared financial supports for initial accreditation
- Technical assistance, as needed
- Application process and contract
- Provider-to-Provider mentorship opportunities

TEMPORARY CLOSURE

- Emergency Temporary Closure. PROVIDER agrees all requests for compensation for temporary closures beyond PROVIDER's control will be handled in accordance with Rule 6M-4.501, F.A.C.
- (2) The coalition may consider reimbursement, in accordance with Federal and State law, for circumstances of temporary closure for individual providers when closure is beyond the control of the provider or the closure is caused by emergency circumstances, including but not limited to the declaration of a state of emergency by federal, state, or local officials, or the closure of public schools in the area in which the provider is located. In no circumstances may a coalition reimburse in excess of the pre-existing approved hours for an individual child during the temporary closure.

 Thursday (10/6/16), Friday (10/7/16) and Monday (10/10/16) reimbursable

• VPK

 Thursday (10/6/16), Friday (10/7/16) and Monday (10/10/16) reimbursable

subsequent emergencies that result in combined total greater than 5 days will require calendar revision

SCHOOL READINESS CONTRACT RATE

No rate = No pay

Review child certificate

- School name
 - Is it your school?
- School location (address)
 - Is it the correct location?
- Approved rate
 - Verify dollar amount



CHANGE NOTIFICATION

- Applies to both VPK and School Readiness Contracts
 - 14 days
- Insurance
 - 10 days
- Notifications

- Should not be used for internal tracking

VPK MONITORING REMINDERS!

Don't look like this during when the monitor shows up!



BE PREPARED FOR MONITORING!

- Check out the ELC website to view the monitoring tool. No surprises[©].
- 5 year records check! Locate your 2011-12 records and keep them on the premises so you can find what is requested quickly.
- Do a self monitoring! Check that what you submitted on 11A and 11B actually match the people assigned in the classroom.
- Use the substitute tracking sheet! Document when you use a sub.

VPK CERTIFICATES

- Please read or review the email Jennifer sent on 9/21/16 for tips on being proactive
- Parents may be confused
- Parent portal is not sophisticated enough to lock.
- Re-enrollments are up to date

VPK ASSESSMENTS

- Compliance
 - Must be within the required deadlines
 - Administration of all VPK children within program
 - Submission of all VPK assessments
 - Submission button must be green; Not submitted if still red

VPK ASSESSMENTS

Deadlines

- AP1 administer within first 30 days of the start of program
- AP1 submission within first 45 days of the start of program.
- AP2 middle of the VPK class's scheduled hours
- AP3 administer within the last **30 calendar days** of VPK class
- AP3 submission 15 days after the last day of program
