Old Business	Finance Report and Waiting List/New Enrollment Update: Sky reviewed the Finance Reports (see attached) with the Board. Due to inaccuracies, in the EF Modernization system, the Coalition does not believe the current waiting list numbers are accurate. Coalition staff are currently reviewing reports in an attempt to analyze waiting list information. The earmarks have been met for the FY 2017.2018: School Readiness direct services 84%; minimum required is 78% VPK Admin 3.89%; maximum allowed is 4% Match dollars are short by approximately \$24,000	No Action/Follow-up

New Business

Children's Services Council Update: The Board discussed the Board of County Commissioner's meeting that was held on July 24, 2018. The Commissioners were to vote on a tax referendum for the Brevard Children's Services Council to be on the November ballot. However, after much discussion and public comments the Commissioners voted against adding the tax referendum to the November ballot.

The Children's Services Council has not met since the July County Commission meeting but a Council meeting has been scheduled for September. The Board will be kept up-to-date with the next steps the CSC will be taking.

<u>VPK Readiness Rates:</u> The Board was informed that the VPK Readiness rates reflect the percentage of screened children a VPK provider has adequately prepared for kindergarten.

The readiness rate is based on the Florida Kindergarten Readiness Screener (FLKRS). This year, Florida administered a new kindergarten readiness screener, STAR Early Literacy.

The Readiness rates results are as follows:

- Statewide
 - -Average score = 541
 - About 1/3 of VPK providers were "low performing"
- Brevard County
 - -38% "low performing" (score of less than 60)

The Board reviewed the STAR Early Literacy Doman Data that was provided by OEL. The Board discussed concerns about the data and follow up discussions that will assist in the understanding of the most appropriate next steps. The Board will be updated as more information becomes available.

Beth Mills will be holding STAR Early Literacy trainings trainings for private providers to have a better understand of the assessment tool and administration process.

<u>EFS Modernization System Update:</u> Coalition staff prepared as much as possible for the new Statewide system that was released on July 2, 2018 (Release 3.0).

The new system is challenging at best which was somewhat expected. However, the Coalition experienced significant data migration issues which compounded issues with system functionality. Coalition staff explained challenges with staff morale and how hard the team is working, despite the challenges with the system. The Coalition has added additional kiosks in the Melbourne and Rockledge offices to assist families.

Khaled Jarrah has informed his directors to be patient with the new system, because the provider side of the new system is not working at this time. However, providers would like to request more communication about the problems with the system. The Coalition staff will send out updates to the providers, as appropriate.

No Action/Follow-up

	Additional School Readiness Allocation: As has been discussed, the Coalition has received its allocation of new federal School Readiness dollars. Brevard has received approximately 1.5m for School Readiness services to be spent by June 30, 2019. Coalition staff is working through a plan on how to spend the funds which will prioritize serving families on the waiting list. The Board discussed possible ways the funds could be spent	
	locally. However, Coalition staff is waiting on OEL for any guidance on how to spend the funds. The Board will be kept up to date with any new information.	
	October Annual Meeting Survey: Sky reminded the Board that October will be the Annual Meeting of the Board of Directors. Officers will be elected at this meeting. If any members are interested, please email Sky.

Director's Report September 2018

State and Office of Early Learning (OEL) Update:

- Sky Beard will be attending a meeting of the Association of Early Learning Coalitions on September 26 in West Palm Beach. The meeting will include an update on strategic planning as well as discussions on important and relevant conversations that all Early Learning Coalitions are facing. While in West Palm, Sky will be attending the First 1,000 Days Conference. The conference includes speakers and workshops related to early childhood topics as well as networking opportunities.
- Dennise Milan, Family Services Administrator, traveled to the Office of Early Learning's office in Tallahassee to assist with troubleshooting and solving the many data migration issues discovered in the EFS Modernization system. After much discussion, it was identified that having a staff member physically present in the OEL office was the most advantageous next step.

Coalition Update:

- The Coalition has completed the selection process for the FY 18.19 Performance Funding Project. The Coalition held a series of informational sessions to educate providers about the Performance Funding Project (PFP) and there was a significant increase in the number of providers that applied. Utilizing criteria established by OEL, 25 providers were selected for participation out of the 38 that applied. Contracts have been signed by providers and the final selection process of their continuous quality improvement (CQI) strategies are underway.
- Coalition staff met with Connie Rivera from the Department of Public Assistance Fraud (DPAF) on September 6. Ms. Rivera is the supervisor assigned to Brevard County. The meeting provided an opportunity to review the Coalition's anti-fraud plan and practices, obtain updates related to the investigative process and establish goals moving forward. The Coalition has processes in place to refer cases of alleged fraud (parent and provider) to DPAF.
- Sky participated in the Department of Children and Families Child Welfare Summit in Orlando on September 6. As part of the statewide conference, the local DCF circuit created an exercise where those working in child welfare were provided scenarios similar to what many families experience. As part of that workshop exercise, the participants "visited" many familiar referral agencies (such as ELC) to experience what many families experience.
- Coalitions staff will be kicking off their United Way campaign in September. If you are interested in

Director's Report October 2018

State and Office of Early Learning (OEL) Update:

Sky Beard will be attending a series of statewide meetings in Miami from October 24 - 26, 2018. On October 24, Sky will be attending a meeting of the Association of Early Learning Coalitions. The next day is a meeting with all ELC Executive Directors and OEL staff. On October 26, Alan Bergman and Sky will be attending the Early Learning Advisory Council (ELAC) meeting where they will be continuing their conversations about strategic planning and visioning for the advisory council.

Coalition Update:

- The Early Learning Coalition will be hosting a Fall Provider Meeting on October 23, 2018 at the
 Department of Health Posey Conference Center in Viera. Two sessions will be held and will contain
 information about the Provider and Family Portals, HB 1091 implementation, contract reminders and
 other relevant information.
- Coalition staff continue discussions with Brandon Properties and Tsark Architecture regarding the establishment of the new Melbourne office building. The Coalition was provided the first view of the building plans and were able to provide feedback to the architect that resulted in some modifications. Revised drawings were submitted and the process is moving forward.
- Coalition staff participated in the Parenting in Today's World workshop hosted by Brevard Public Schools on October 6, 2018. The sessions provided parents and caregivers an opportunity to learn about a variety of topics as well as interact with many community agencies that support children and families.
- The Coalition will once again be partnering with The Beach 98.5FM for a toy drive to benefit currently enrolled School Readiness families. The toy drive will include two Fill the Truck events throughout the community. More details will be provided as they become available.
- In continued partnership with United Way of Brevard, four Brevard County early learning providers were selected to participate in the Business Leadership Institute hosted by the ELC of Orange County. The providers will attend monthly sessions through December that will focus on business planning, marketing, human resources and other business related topics.
- Coalition staff are saddened that one of our coworkers, Robert Damm, passed away recently. Robert served as our maintenance technician and worked alongside us to make the Coalition a great place to be. Coalition staff attended his military funeral service and are in the process of collecting gift cards to support his children.

Evaluation of Direct Enhancement Services

COMPREHANSIVE CONSUMER EDUCATION

Describe how the Coalition coordinated resource and referral programs specifically related to the provision of comprehensive consumer education to parents and the public regarding participation in the school readiness program and parental choice.

During fiscal year 2017 – 2018, the Early Learning Coalition of Brevard continued its efforts to provide high quality Child Care Resource and Referral services to the community. In addition to in-house trainings conducted throughout the year, the Coalition also participated in local CCR&R training conducted by OEL CCR&R staff. The training was requested in order to provide updated information and general CCR&R information to newly hired staff as well as serve as reminders to seasoned staff.

The Coalition continued to highlight CCR&R services through its website, emails and community events. Community events such as book fairs, health fairs, developmental screening events and family fun days provided an opportunity for the Brevard County community to learn more about early learning related topics and services provided by the Early Learning Coalition of Brevard. In addition, the Coalition hosted a community screening of "The Raising of America." This documentary was shown at no cost on December 30, 2017 at a local movie theatre. A panel discussion followed, facilitated by the Editor of Florida Today newspaper.

PROVIDER FINANCIAL SUPPORTS

Provide a list of grants, awards, or bonuses offered to school readiness program providers to assist them in meeting applicable state requirements for child care performance standards, implementing developmentally appropriate curricula and related classroom resources that support curricula, providing literacy supports, and providing professional development.

During FY 17.18, the Coalition continued to support participation and payments related to the Performance Funding Project. The Coalition also held its 9th annual child care provider conference, *Renew the Passion*, on April 14, 2018 at no cost to providers. The Coalition continued its offers of fiscal and supplemental supports through the Accreditation Support Grant program. Three providers were selected to receive financial assistance with the accreditation process, technical assistance from Coalition staff and mentoring alongside another accredited provider. During the fiscal year, no providers were at a stage in the process where financial supports were requested. Coalition staff will be monitoring the

effectiveness of the Accreditation Support Grants during the remainder of the current fiscal year.

TRAINING AND TECHNICAL ASSISTANCE

Provide a list and description of the trainings and/or technical assistance activities the coalition offered to school readiness program providers, staff, and parents in the following areas:

- Early Learning Standards
- Child Screenings and Assessments
- Developmentally Appropriate Curricula and Character Development
- Teacher-Child Interactions
 - July 7, 2017: Back to Basics Workshop: During these scheduled workshops, participants explored parent communication in the 21st Century. Teachers also explored how music and movement affects children and how to use music in meaningful ways in the classroom.
- Age-Appropriate Discipline Practices
- Health and Safety
- Nutrition
- First Aid
 - June 27, 2018: ELC Brevard offered a limited number of no cost CPR & First Aid Certifications to 23 early childhood staff members employed with School Readiness contracted providers in Brevard County. ELC offered this training opportunity to assist contracted providers with the new DCF CPR and First Aid regulations effective October 1, 2018. The same training was also provided to Coalition staff.
- Recognition of Communicable Diseases
- Child Abuse Detection and Prevention

In addition, the Coalition hosted its Fall Provider Meeting on October 24, 2017 and its Spring Provider Meeting on March 9, 2018. These informational sessions provided an opportunity for providers to learn more about what is happening in the world of early learning and stay updated on current topics.

QUALITY ACTIVITIES FOR INFANT AND TODDLER CARE

Provide a description of the quality activities and services the coalition provided to enhance infant and toddler care.

A staff member of the ELC of Brevard was significantly engaged in OEL's Infant Toddler Network during the fiscal year. She participated on regularly scheduled calls and attended face-to-face meetings when offered. In addition, that staff member and the CCR&R Coordinator attended the Mind in the Making Train the Trainer and have since conducted the first training series using that framework. The first training series utilizing Mind in the Making materials was specifically focused on Infant Toddler teachers. Discussions have occurred regarding the need for more targeted Infant Toddler professional development activities in the future.

In addition, the topic of available, high quality infant care has continued with the ELC of Brevard's Board of Directors Quality Committee. It was identified that Coalition staff were beginning to see gaps in available infant care in some areas of the community. Discussions have occurred and will continue about strategies to increase the availability of high quality infant programs in the community.

MONITORING

Describe the process for monitoring of compliance with, and enforcement of, applicable state and local requirements.

The Coalition continued to support providers through the required monitoring events during the fiscal year. School Readiness and VPK providers were monitored utilizing the required tools and in compliance with the established requirements. Again this year, the Coalition supported providers by offering two trainings that were designed to provide a positive monitoring experience for all involved. *School Readiness Monitoring: Heads Up! Triumph or Tragedy?* and *How to Become a VPK Monitoring Success Story!* were well attended and the partnership approach was appreciated by providers. The School Readiness monitoring training was held on July 11 and 25, 2017 and the VPK monitoring training was held on July 13 and 27, 2017. The intent of these trainings is to take the guess work out of School Readiness and VPK monitoring by assisting providers with the content of the monitoring tool with a focus on encouraging successful monitoring experiences.

The Coalition also continued a positive working relationship with the local DCF licensing staff. Communication occurs regularly regarding potential licensing violations, program questions and other areas where sharing information leads to greater compliance.

The Coalition hosted a series of informational sessions related to the Performance Funding Project on May 23, 2018, June 4, 2018 and June 6, 2018. The sessions were hosted for providers to come and learn more about Performance Funding and ask any questions they may have about the program. The intent was to encourage providers to participate, as

appropriate, and also aide with their success in the program if they were selected. Similarly, the Coalition hosted sessions on June 19 and 26, 2018 related to the School Readiness Program Assessment process.

INCLUSION

Describe the activities the coalition has implemented to promote inclusive child care including responding to Warm-Line requests by providers and parents and providing developmental and health screenings to school readiness program children.

The Coalition continued to offer inclusion and development screening services to the Brevard community. Inclusion staff responded to Warm-Line requests and continued to implement a solution-focused, collaborative team approach for providers and families that benefited from additional supports. Meetings with parents were scheduled together with the teacher/director and inclusion/screening staff in order to ensure that there was agreement on the plan put in place to address the concerns observed in the classroom. The Inclusion Specialist also conducted trainings at multiple provider locations related to inclusion services and specific topic requests, such as managing challenging behaviors.

Developmental screenings were also provided to all enrolled School Readiness children utilizing the ASQ-3 and ASQ-SE, when deemed appropriate. The Coalition continued to utilize ASQ Enterprise, an online parent access option for completion of the required ASQ. For the majority of families, this approach appeared to have been a sufficient way to obtain developmental screening information on children in the School Readiness program. For families where a face-to-face screening or discussion was warranted, Coalition staff provided that level of service as well.

In addition, Coalition staff continue to be active community partners with the local Help Me Grow program. In collaboration with 2-1-1 Brevard, Early Steps, Head Start, Brevard Department of Health, Brevard Public Schools, United Way of Brevard and additional community partners, Help Me Grow is actively working to identify children in need of developmental screenings who would have otherwise been missed. Coalition staff are members of the local Help Me Grow Steering Committee and participate in joint community events to support an increase in developmental screening opportunities in the community.
