Policy Overview Grievance and Whistle Blower	 Alan Bergman goes on record saying that the whole policy was circumvented and he received no complaints prior to the October 15, 2019 Board meeting, Part of the investigation is whether the policy was followed. Alan Bergman states we have a copy of Laura's response. Do we have a Grievance Policy in place? Laura Gambino read the ELC Grievance Policy Section 13 Item D. Louis Wilson, State of Florida Board Certified Labor and Employment Attorney (Ford Harrison LLP) defines Whistle Blower Policy and states that after reading the complaints from two employees at the Annual Board Meeting, he does not feel they rise to Whistleblower. Laura Gambino, Executive Director refutes all claims that she created a hostile environment in her 4 months of employment. These employee complaints are a direct response from an Independent Consultants' findings that were presented to the Executive Committee on October 7, 2015. Now with an IG complaint that appears to come from a disgruntled employee or a former employee the agency is placed at risk. Dr. Beth Mills assures Laura Gambino that one of her staff or former employees did not contact the Inspector General with the state of Florida regarding the banking authorization, she herself did. Eneida Colon, CC&R Coordinator, ELCB states there is more to this than just the three here today. She would like to see interviews with other ELBC employees. Gina Sousa, Director, Program Initiatives, ELBC, stated she would like the investigator to have no prior dealings with ELCBC.
